Cole, Lake take year-end titles

Robert L. Cole, Jr., and Scott Lake ranked as the leading owner and trainer

in Maryland in 2006.

Mr. Cole, honored by the MTHA as outstanding Maryland owner, concluded the season with 49 wins from 116 starts at Maryland tracks, a winning ratio of 42.2 percent. On the national list, he ranked third by wins and among the top 10 by earnings.

The nation's leading trainer by wins (with a total of 528), Mr. Lake recorded 114 wins at Laurel and Pimlico. He captured the training title at three of the four meets, while scoring with 29.01 percent of his starts, the best percentage of any Maryland trainer.

WBAL wins Eclipse Award

WBAL Radio in Baltimore won an Eclipse Award for its coverage of the 2006 Preakness.

This is the seventh Eclipse Award for the station, which also took honors in 1978, '81, '84, '97, '01 and '04.

Thoughts and comment

All of the major racing states surrounding us now have slots, which puts Maryland in a difficult position, to say the least.

The situation looks bleak. But our industry remains strong, largely through the efforts of hard-working and talented horsemen and track management who, through great effort and determination, produce some of the best racing in America.

The task force known as Keep It In Maryland, or KIM, is working to enhance our industry's strengths and overcome some of its weaknesses during these troubled times.

KIM was the brainchild of our current Maryland Racing Commission Chairman John P. McDaniel (who orchestrated last year's agreement between the Thoroughbred and harness interests).

Already, KIM has accomplished its immediate goal of identifying the key issues. These findings will be presented to the governor and the legislature in the near future.

Highlights include:

- The desperate need for greatly enhanced purses and breeders' funds—

MJC's 2006 wagering figures don't tell the whole story

While the 2006 wagering figures released in early January by the Maryland Jockey Club showed a positive trend in business, they don't change the fact that Maryland's purses are lagging behind those in surrounding states.

"What they do indicate is that Maryland is holding its own in these difficult times. Much of the credit for that goes to our local horsemen, who deliver a high-quality racing product on a daily basis," said MTHA President Richard Hoffberger.

Handle on Maryland's simulcast signal at out-of-state locations rose dramatically, and the in-state live handle increased by a small percentage.

"It's a tribute to the loyalty, and the professionalism, of our owners and trainers," noted Mr. Hoffberger. "The racing office, and in particular Racing Secretary Georganne Hale, also had an instrumental role in developing a product that we can all take pride in."

"All of us are heartened that out-of-state fans enjoy betting on our races, and we sincerely hope this trend continues. But the situation in regard to our purses remains dire."

Following Mr. Franzone's report, Commission members and industry representatives discussed the issues at length, all agreeing upon the severity of the economic pressures.

"The industry needs help *this year*," warned MTHA counsel Alan Foreman, who serves on the KIM task force. "That is the message we'll be taking to Annapolis. If something is not done immediately, many of our horsemen will leave. Once they're gone, it won't matter what happens. They won't come back."

Immigration reform legislation could alleviate problems for horse industry

MTHA provides assistance

The MTHA, along with other horsemen's groups throughout the country, is paying close attention to legislation introduced in Congress on January 10 that would lead to comprehensive reform of the nation's immigration laws for agricultural workers.

The American Horse Council (AHC) reports that the legislation, known as the AgJobs bill, would satisfy most of the concerns of the horse industry regarding the H-2A Agricultural Worker program that allows agricultural workers to enter the United States to do seasonal labor.

Bills have been introduced in the Senate by Dianne Feinstein (D, Calif.) and Larry Craig (R, Idaho) and in the House by Howard Berman (D, Calif.) and Chris Cannon (R, Utah).

Philadelphia Park slots handle \$175.2 million in first three weeks

Business has been brisk on Philadelphia Park's slots floors, which opened on December 19.

Pennsylvania's first Thoroughbred racino, Philadelphia Park has 2,076 machine, which reportedly handled \$175.2 million on slots during the first three weeks. That figure translated into gross revenue of more than \$15.1 million—of which \$1.8 million will be directed to purses at Pennsylvania tracks.

During the same period, Mohegan Sun at Pocono Downs, which opened in November as Pennsylvania's first slots facility, generated approximately \$98 million in slots wagers for gross revenue of more than \$9 million.

Under the law governing Pennsylvania's slots program, 12 percent of the gross revenue goes toward purses, the breeding fund and horsemen's health, benevolence and pension programs.

Eventually, seven race tracks and five stand-alone sites will operate slots emporiums in that state, but Pocono Downs and Philadelphia Park are the only two currently in operation. Within the next several months, three sites are expected to open their doors—Harrah's at Chester Downs in Chester, Presque Isle Downs in Erie and The Meadows in Washington County.

Penn National's slots area is scheduled for completion in late 2007.

Annual registration for the MTHA's Backstretch Pension Program begins in March. Exact dates will appear in next month's newsletter.

The plan is open to all individuals employed in the care of horses on the backstretch.

Employees do not make financial contributions to the plan. However, registration is required every year.

Grover G. (Bud) Delp: Maryland trainer made his bid for lasting fame



Grover G. (Bud) Delp, the Maryland-based Hall of Fame trainer who guided the career of superstar Spectacular Bid, died on December 29 at the age of 74.

Mr. Delp, who came up under the employ of his late stepfather, longtime horseman Raymond Archer, achieved success with all levels of horses, from lowly claimers to consistent top performers, and is credited with 3,674 career wins (ninth on the all-time list). He developed 70 stakes winners. But for many racing followers, his name is linked with only one horse—Spectacular Bid.

A three-time champion who won the 1979 Kentucky Derby and Preakness, and came back the following year to earn Horse of the Year honors, Spectacular Bid, trained by Delp throughout his career, earned \$2,781,608 while winning 26 of his 30 starts, including 23 stakes wins.

Delp received the Eclipse Award as the nation's leading trainer of 1980, and was inducted into racing's Hall of Fame in 2002.

The best horse trained by him in recent years was Include, winner of the 2001 Pimlico Special.

Mr. Delp's survivors include his wife, Regina, and son Cleve, who are carrying on his stable; and his brother Richard, who retired several years ago after a long and successful career as a trainer in Maryland.

Horsemen's Counseling Program offers confidential drug-testing

Trainers are reminded of the drug-testing services available through the Horsemen's Counseling Program.

Bill Borchardt, coordinator of the program, encourages trainers to contact him for confidential drug-screening services at the following times:

- Upon hiring a new employee.
- As a follow-up to earlier positive drug tests.
- When an employee is injured on the job.
- Whenever impairment is suspected.

"Trainers should keep in mind that they are actually doing the employee a favor by sending him to us," said Mr. Borchardt, who provides both testing and counseling through the University of Maryland Employee's Assistance Program.

Mr. Borchardt will make special arrangements to meet with individuals who need immediate services.

posed reform would:

- Streamline the admission process.
- Create a process by which workers could be authorized to stay for a longer period.
- Provide for a secure identity and work authorization document for H-2A aliens.

The legislation now before Congress is the same bill that the Senate passed in

2006.

Concluded the AHC: "Immigration reform legislation has been debated through the last several Congresses. It is complicated legislation that generates a great deal of emotion."

"Whether a final bill can be passed remains to be seen, but at this point the AgJobs bill seems to have the broadest and most bipartisan support."
