Ban on shippers from Virginia may be ended

The ban on horses shipping to Maryland tracks from Virginia was expected to be lifted on Wednesday, March 21, pending the results of tests from two Virginia farms linked to a recent outbreak of equine herpesvirus (EHV-1) in Virginia and Florida.

"We're hoping to begin accepting horses from Virginia as usual," said the Maryland Jockey Club's racing secretary, Georganne Hale.

MTHA fights for the industry in Annapolis

With the 2007 legislative session entering its final weeks (and due to adjourn on April 9), MTHA representatives are engaged in intense lobbying efforts in Annapolis.

"We are cautiously optimistic about the chances for successful slots legislation—if not this year, then in 2008, as part of a major tax package," said MTHA President Richard Hoffberger.

"Meanwhile, our focus is on securing a purse enhancement from the state that will allow us to keep our program intact until those issues can be worked out," stated Mr. Hoffberger. "We have done our very best to make it clear to state officials that the competition we face from surrounding states is very real, and will be devastating to us unless the state takes action to put us on a level playing field."

MTHA representatives testified before the Senate Budget and Taxation Committee on March 6 and the House Ways and Means Committee on March 8, as well as at an earlier Senate Finance Committee briefing on January 25.

Various racing-related bills are under consideration.

Among them is House Bill 1342, sponsored by Delegate Nancy J. King (D, Distr. 39, Montgomery County), et al., that would direct a portion of Lottery revenue toward purses and breeders funds.

That bill has drawn favorable comment from subcommittee chairman Frank S. Turner (D, Distr. 13, Howard County), who told the Baltimore Sun he believes the House is "committed to helping" the horse racing industry this year.



Magna announces major business moves

Magna Entertainment Corp., principal owner of Laurel/Pimlico, has entered into a major cooperative agreement with one of its largest business rivals, Churchill Downs.

The two companies are forming a new entity, TrackNet Media Group LLC, that will buy content from and sell content to third parties.

"By creating a single cost-effective organization to more efficiently buy and sell racing content, TrackNet Media will have the resources to pursue wagering integrity and security objectives, with a view toward generating revenue for horsemen and race tracks that create content," stated a joint press release.

"To better serve our customers and grow the financial return for our horsemen, Magna Entertainment and Churchill Downs believe the time has come to make our simulcast content available through as many trusted and eligible distribution platforms as possible," said Magna Entertainment's chief executive

officer, Michael Neuman. "In doing so, we can maximize the content available to customers and the revenue available to the horsemen and race tracks who create the industry's content."

At the same time, it was announced that Churchill Downs has purchased a 50 percent interest in Magna Entertainment's horse racing TV channel, HRTV.

New Magna CEO

Michael Neuman has been named chief executive officer of Magna Entertainment Corp (MEC). He succeeds Frank Stronach, who had served as interim chief executive officer since March 2006.

Before joining MEC several months ago, Mr. Neuman was most recently president and chief operating officer of EchoStar, which operates DISH Network in the United States.

Dale Austin, longtime turf writer, retires

Dale Austin, who covered racing for the Baltimore Sunpapers for 29 years and most recently wrote a weekly racing column for *The Capital* in Annapolis, says he's now "completely retired."

Mr. Austin, 74, grew up in Oklahoma, (near Blue Ribbon Downs, as he explains it) and became a part-time sports reporter for *The Washington Post* while serving in the Army at Ft. Myer in northern Virginia in the 1950s.

When the *Post's* racing reporter quit, he moved into covering racing and horse shows, he recalls, and that experience led to employment in the publicity department at Laurel, as well as at two Maryland harness tracks.

In January 1962, Mr. Austin was hired at the *Sun* to fill a vacancy created when its longtime racing writer Snowden Carter left to become general manager of the Maryland Horse Breeders Association as well as editor of *The Maryland Horse* magazine.

Mr. Austin's career at the *Sun* lasted until December 1991, when he accepted a buyout and moved over to become a staff writer for the *Racing Times*, a publication that soon went out of existence. He then worked in the publicity department at Laurel/Pimlico for five years, serving as publicity chief at Colonial Downs for that track's inaugural meet in 1997.

Since 1998, his work has appeared in the *Capital*.

Mr. Austin is a former president of both the Maryland Racing Writers Association (now Maryland Racing Media Association) and National Turf Writers Association.
