Insurance fee set at \$225 for 2009

The fee that each Maryland owner and trainer pays to provide jockeys' workers' compensation coverage has been set at \$225 for 2009. This is a decrease of \$25 from 2008 and \$150 less than was required for 2007.

The fee is set on an annual basis, and determined by the number and types of claims and by the number of licensees among whom the cost is distributed.

Meanwhile, as always, the advantages of Maryland's workers' compensation program for jockeys far outweigh the fee.

Maryland was a pioneer in securing this vital coverage. It is provided through a nonprofit corporation known as the Maryland Jockey Injury Compensation Fund, Inc., established in 1986 and managed by the Maryland Racing Commission.

Steroid ban begins January 1

Maryland's steroid ban takes effect January 1, 2009. The new rule mirrors the Racing Medication and Testing Consortium's model rule, and is in line with rules currently in effect in neighboring states, including Pennsylvania.

The system of penalties and grace period have not yet been announced. However, monitoring has been conducted for several months and all results were within the required limits, according to Maryland Racing Commission executive director Mike Hopkins.

joining forces with trainer Dale Capuano. Mr. Haynes and his racing manager, Jayne Marie Slys, have campaigned four stakes winners—two in 2008—with the star being Heros Reward, a \$20,000 claim who has won nine stakes and earned well over \$800,000 since joining the stable. Heros Reward carried Maryland's hopes in the \$1 million Breeders' Cup Turf Sprint last October and gave a good account of himself while finishing fifth.

Maryland has contributed in large measure to the national prominence of Scott Lake, who has finished either first or second in the country by number of wins each year since 2000. Mr. Lake led the Maryland trainers' ranks in 2005, '06 and '07, and he's on course for a fourth consecutive title in 2008. Laurel Park is one of five tracks where Mr. Lake currently maintains divisions. He has about 40 horses at Laurel under the care of assistant Hugh McMahon.

As stable foreman for Chris Grove, Mr. Mancilla has had a hand in

developing some of the most accomplished Maryland performers of recent years, including millionairess Silmaril and Lexi Star.

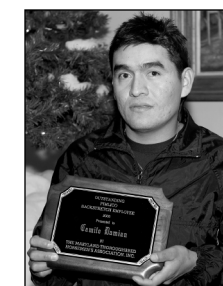

Until then, he'd had no experience with horses.

Last summer his skills were put to the test when he was the only groom working for Ms. Robinson at Colonial Downs.

"We shipped a lot of horses back and forth. Some of them needed special treatment. Camilo handled them all. And we won a lot of races," says Ms. Robinson.

Gov. O'Malley appointed as chairman Donald C. Fry, president and CEO of the Greater Baltimore Committee.

Mr. Fry served in the House of Delegates from 1991 to 1997 and went on to a term in the Senate, representing Harford and Cecil counties. He is one of a

few legislators to have served on each of the major budget committees of the Maryland General Assembly.

Gov. O'Malley's other appointees are Linda Read of Cecil County, secretary and treasurer for Paul Risk Associates, a commercial builder, and Ella Pierce, a former purchasing agent for Baltimore.

Mr. Miller appointed James H. Taylor, Jr., a retired Prince George's County Circuit Court judge, and Robert Neall, a former state senator and Anne Arundel County Executive.

Mr. Busch named to the panel Thomas P. Barbera of Montgomery County, who recently retired as chief executive officer for UnitedHealthcare's Mid-Atlantic region, and D. Bruce Poole, a lawyer from Washington County and a former state legislator.

Breeders' Cup suspends 2009 stakes program

Projecting a \$10 million drop in revenue for 2009, the Breeders' Cup has announced that it will suspend all Breeders' Cup funding for stakes during the upcoming year.

The reduction was necessary in order to maintain the Breeders' Cup World Championships purses at their current level, according to officials within the organization.

The Breeders' Cup also intends to slash more than \$5 million from its television and marketing budget.

Several changes in the schedule of nominating fees were also announced for next year's Breeders' Cup World Championships to be run November 6 and 7 during the Oak Tree meet at Santa Anita.

Racing schedule for 2009 expected to follow established pattern

The Maryland Racing Commission has approved a schedule of racing for 2009, but the exact dates when Laurel and Pimlico will conduct live racing have not been determined beyond the Laurel winter meet.

Laurel has announced plans to offer 59 days of live racing for the 15-week meet that begins on Thursday, January 1 and ends on Saturday, April 11.

Racing will take place four days a week, on a Wednesday-through-Saturday schedule, with some holiday exceptions.

It is expected that Pimlico will open in mid-April, and the remainder of the racing schedule will mirror that of recent years, including a 10-day mini meet at Laurel in August.

However, if business falters, adjustments could occur.

Morgan W. (Sonny) Wayson, Jr., an owner/breeder in Maryland since the 1970s, died on November 18 at the age of 69. He and his wife, Janet Leatherbury Wayson, campaigned a number of stakes winners, most recently homebred Lightning Paces and Apple Special.

Gerald J. (Jerry) Stautberg, 79, who successfully owned and bred horses in recent years with his wife, Caroline Stautberg, died on December 7. Mr. Stautberg was best known as the proprietor of Jerry's Chevrolet, the Baltimore auto dealership that he founded in 1957.

New shoe rule to take effect January 1

Starting January 1, 2009, the Maryland Jockey Club will put into effect a new rule regarding shoes worn by a horse during a race.

A horse may not be permitted to start if it has shoes with toe grabs which:

(1) are greater than 2 millimeters in height; or

(2) contain bends, jar calks or any other traction device worn on the front hooves.
