MTHA responds to criticism regarding Pimlico closing

When the Maryland Jockey Club (MJC) announced its decision to close the Pimlico stable area as of August 31, many Pimlico horsemen were understandably distraught.

The MTHA does not, in any way, downplay the severity of the situation that some Pimlico horsemen are facing.

However, it is unfortunate—and completely unfair—that the MTHA has become a lightning rod for horsemen's protests regarding the Pimlico closing.

It is largely through the efforts of the MTHA that the Pimlico stable area has remained open year-round, with facilities for training, until now.

For many years, the MTHA has approved expense contributions to the MJC totalling millions of dollars. In exchange for the allocations, the MTHA required that Pimlico remain open for stabling and training.

There is only a minimal expense con-

tribution this year, because our Purse Account can't afford it. For that same reason, all of our open stakes have been eliminated from the fall calendar.

MJC's parent company, Magna Entertainment Corp., is facing grave financial problems of its own. Keeping three separate training facilities open has been a stretch for the MJC, and now it has come to a breaking point in regard to Pimlico.

MTHA leaders are surprised that so many Pimlico horsemen apparently have been unaware of this organization's long-standing commitment to their welfare.

Magna made the decision to close Pimlico; the MTHA did not agree to let it happen, but could do nothing to avert it. However, MTHA representatives have negotiated on behalf of Pimlico horsemen to ensure that those who support the Maryland racing program receive priority when seeking appropriate stall assignments at Laurel and Bowie.

Fall stakes program dismantled

Because of a shortage of funds in the Purse Account, the Maryland Jockey Club and MTHA have agreed to eliminate all open stakes from the fall schedule.

The Frank J. De Francis Memorial Dash, one of Maryland's three Grade 1 races, will not be run in 2008. Also on hiatus are the venerable Laurel Futurity and Selima Stakes and Grade 3 Safely Kept Stakes.

"It's a drastic step, but absolutely necessary in order to preserve our overnight program," said MTHA President Richard Hoffberger. "Hopefully, the referendum will pass and things will begin to turn around next year."

The 17-week fall meeting will be conducted at Laurel from September 4

Kozak will be missed

Maryland horsemen will say a reluctant good bye to Glen Kozak, who has served as superintendent of facilities for the Maryland Jockey Club since 2005.

Mr. Kozak will leave at the end of August for a similar post at the New York Racing Association.



about a year ago in Vegas has become the highest-grossing restaurant in the U.S.

To be seated at a small cocktail table in the nightclub you have to buy a bottle of liquor—and the prices start at \$400 a bottle. On big weekends it costs \$5,000 for a table next to the dance floor.

Amazingly, the restaurant is sold out every night, with long lines of people waiting to get in.

The point is, we are in the entertainment business and slots will provide us with an opportunity to integrate our form of entertainment—Thoroughbred racing—into a total package that will only further grow our core business.

Would anyone mind if we have an arena for high-class nightclub acts at Laurel, and it generates another \$10 million a year for purses?

But there is a catch. None of this can happen without widespread support for the referendum.

We must rally behind lobbying efforts for the referendum.

Wishing, by itself, won't get us anywhere. We must suspend all of our differences, avoid our usual infighting and

unite behind this effort.

One of my favorite figures in history is Winston Churchill, the British Prime Minister who rallied his nation to fight off the Germans in World War II.

Churchill didn't spend a lot of time trying to figure out how they got in that situation; the United Kingdom just took on the Luftwaffe.

It was their "finest hour" and so too can this point in time be ours.

Please don't count on the "other guy" or "fat cats" to ensure that the ref-


erendum passes. It is every man and woman on deck to win this fight.
