## Rosecroft's future existence more doubtful than ever

The Maryland Racing Commission conducted a hearing on April 13 to determine whether Rosecroft Raceway, the bankrupt harness track in Oxon Hill, would be allowed to retain its operating license.

Ultimately, the Commission voted 5-1 (with Chairman John Franzone casting the dissenting vote) to allow Rosecroft to stay open until July 1.

A \$350,000 loan from prospective buyer Mark Vogel, and \$150,000 from Cloverleaf Standardbred Owners Association, reportedly will be used to keep the track afloat until then. Mr. Vogel's desire to own Rosecroft appears based on his vision of its future as a casino.

Rosecroft's current owner, Cloverleaf Enterprises Inc., pursued legislation in the 2010 General Assembly to introduce table games (see *Thoughts and comment on page 4*). CEI president Kelly Rogers had warned that Rosecroft would be forced to close this month if the legislation did not pass.

Rosecroft has not conducted a regular live racing program in nearly two years, and exists as a simulcast facility.

Mr. Franzone expressed serious concerns as to Rosecroft's financial viability, and questioned the rationale for granting a race track operating license for a facility that appears to have little, if any, impetus toward live racing.

## Arundel Mills casino is off the drawing board—at least for now

The Cordish Co.'s proposed casino near Arundel Mills mall is now officially on hold, pending the outcome of an Anne Arundel County referendum in the November election.

On April 1, the Anne Arundel County Board of Elections announced that 22,967 signatures of those opposing the mall slots site are valid, and authorized a referendum that will allow county voters to decide for or against the mall casino in the November election.

Within a few hours of the Elections Board's decision, Anne Arundel County Executive John R. Leopold ordered county officials to cease their review of Cordish's plans, bringing progress on the Arundel Mills casino to a standstill.

Developer David L. Cordish is attempting to revive his bid. He has filed a lawsuit claiming that fraud was involved in the gathering of the signatures. That case will go to court next month, and if Cordish is successful the referendum could be called off.

However, if the referendum is held and it goes against the Cordish site, the slots commission will reopen bidding for the Anne Arundel license; zoning will also have to be secured for another site.

"The MTHA's position remains the same as it has always been—that is, slots belong at the race track," said MTHA President Richard Hoffberger. "While

## Maryland's first two slots sites to open this fall

Maryland's first two slots facilities are on track to begin doing business this coming fall.

Penn National Gaming (PNG) expects to have its site in Cecil County up and running in mid to late October, according to the company's director of public affairs, Karen Bailey.

"The building is enclosed and the roof is on; the floors are poured and the drywall is finished," said Ms. Bailey in mid-April.

Encompassing about 65,000 square feet, the Penn National casino will open with 1,500 slot machines, a buffet restaurant and additional food stations. It will feature an art deco design similar to PNG's Hollywood Casino at Penn National.

The Penn National site is located near

the I-95 Perryville exit, at the intersection of I-95 and Rte. 222. Plans call for it to serve as the anchor to a mixed-use development to be built by Stewart Associates.

The announced target date for the Worcester County site, at Ocean Downs harness track near Ocean City, remains late November or early December. But it possibly could open sooner, said Joe Cavilla, who will manage the 25,000 square-foot casino for owner Bill Rickman Jr.

Ocean Downs will house 800 slot machines initially. Its casino will be located in the former grandstand, which is undergoing a complete remodeling. The existing clubhouse will continue as a racing/simulcast facility at least in the early phase, said Mr. Cavilla.

The AHC is the major organization providing representation for the Thoroughbred industry in the U.S. Congress.

no one wanted another delay, the industry will be in a much better position going forward if Laurel Park can take advantage of the renewed opportunity to secure slots.

"Slots at either Arundel Mills or Laurel will generate revenue that boosts purses, but the track operator would struggle financially without slots and with competition from a nearby casino. This could create a situation where the track is worth more for development than as a race track. Ultimately, that could mean we'd have no place to race for those higher purses. The current scenario gives us a chance to have a successful racing program over the long term."

## Bonus among highlights of this year's Preakness week

As announced in last month's newsletter, a special purse bonus will be in effect at Pimlico on Black-Eyed Susan Stakes Day (May 14) and Preakness Day (May 15).

The bonus will apply to all dirt races, with the exception of stakes, in which more than eight betting interests start.

A 10 percent bonus will be applied to the total purse if nine betting interests start, 20 percent if 10 betting interests start, 30 percent if 11 betting interests start, and 40 percent if 12 betting interests start. The bonus is capped at 40 percent.

### Post times

First post on Black Eyed Susan Day is 12:15 p.m.

On Preakness Day, horses go to post for the first race at 10:45 a.m.

## Pimlico reaching out to fans with online chats

Historic Pimlico Race Course is making use of modern technology this spring with a new program offering interactive online chats between racing fans and experts.

The Maryland Jockey Club has joined with [www.HorseplayerNOW.com](http://www.HorseplayerNOW.com) to provide the chats for the first 17 days of the meeting, through Preakness Day, May 15.

"Horse Player NOW has had success in boosting the handle at Churchill Downs during its 2009 fall meet and is currently working with XpressBet for high-profile stands at Santa Anita, Gulfstream and Keeneland," said MJC president Tom Chuckas. "This partnership

will prove beneficial to the track brand as well as the bottom line, which is increased wagering."

Horse Player NOW is capable of accommodating tens of thousands of participants simultaneously. The race-day chats may be accessed at [www.pimlico.com](http://www.pimlico.com). They begin 30 minutes before the first race. Discussions continue until the final race of the day.

Handicapping information and advice comes from Horse Player NOW's Jeremy Plonk, Joe Kristufek, Brian Spencer, Brian Nadeau and Bob Neumeier. Additional analysis is provided by Pimlico announcer Dave Rodman and track handicapper Frank Carulli.

## Medication rulings now available for viewing on RMTC Web site

The Racing Medication and Testing Consortium (RMTC) has begun posting recent medication rulings on its Web site at [www.rmtcnet.com](http://www.rmtcnet.com).

Information is gathered from racing commissions throughout the country, and includes names of the trainer and horse, the state where the violation occurred, the penalty, and a description of the medication that was involved.

"Racing fans and participants have voiced their desire for transparency and

easy-to-access data on drug-related rulings," said RMTC executive director Dr. Scot Waterman. "To our knowledge, this is the only database in existence that allows viewers to see not only the infractions but also a description of the possible uses and effects of the drug in the horse. We hope that this will begin the process of better clarifying the difference between medication management mistakes and more serious drug violations."



## Colors and papers must be picked up before end of Pimlico meet

Horsemen are reminded to pick up racing silks and Jockey Club registration papers before the end of the Pimlico meet.

These items will not be available for pick-up during Maryland's live racing break, which begins on Pimlico's closing day, May 22, and extends until August.

## Thoughts and comment

**N**o news is good news, as the saying goes. For Thoroughbred horsemen, that surely rings true regarding the 2010 legislative session.

The state legislature adjourned for the year on April 12 without passing any racing-related bills. Considering that several of the bills brought before lawmakers this session would have had a long-term negative effect on the Thoroughbred industry, horsemen should be pleased with the outcome.

Bills were introduced to negatively alter the formula for allocation of slots revenue to purses and breeders' funds, and to eliminate it completely.

Another bill sought to tweak the dis-

tribution of slots revenue in favor of the harness industry. Efforts also were made to dismantle the Maryland Racing Commission.

Perhaps the most debatable came in the form of a bill that would have opened the door to casino-type gaming at Rosecroft. It passed the Senate and died in a House committee. The time undoubtedly will come when the legislature is again asked to approve casino-type gaming. However, it makes far better sense to consider it for all of Maryland's gambling locations and not just Rosecroft.
