Stronach Takes Full Control of MJC: 2012 Dates Not Assured

The co-owners of Laurel Park and Pimlico Race Course have ended their tumultuous one-year partnership, leaving Maryland's Thoroughbred race tracks with a single owner.

Penn National Gaming agreed to sell its minority stake in the Maryland Jockey Club to horse owner and breeder Frank Stronach.

The transaction allows Penn Gaming to divest itself of an investment that soured shortly after the company bought the 49 percent stake in the two tracks early in 2010.

The stake was transferred to Stron-MJC Limited Partnership on June 30.

After the transaction closed, Stron-MJC was granted a racing license by the Maryland Racing Commission for the remainder of 2011. However, company representative Greg Avioli was non-committal on next year's race dates during July's MRC meeting.

This is in stark contrast to the agreement hammered out in April when the Maryland General Assembly passed legislation requiring 146 days of live racing per year through 2013. In return for these race date assurances, the state agreed to divert up to \$6 million annually in slots revenue allocated for racetrack improvements to help support the day-to-day operations of the Maryland Jockey Club. Additionally the MTHA allotted over \$1.5 million toward operating expenses for 2011.

Lucy Acton – Maryland racing advocate – gone too soon

Lucy Acton, the writer and publisher of this newsletter for the last 21 years and editor of the award-winning *Mid-Atlantic Thoroughbred*, died Tuesday, June 7. She was 63.

A respected journalist throughout the regional horse industry and beyond, Acton remained dedicated to its causes almost to the very end. Diagnosed with a rare form of cancer several years ago, she underwent surgery and treatment and continued working with typical vigor, cheer and quiet determination. She officially resigned from the *Mid-Atlantic Thoroughbred* June 1 and died six days later. Acton served as longtime secretary of the Maryland Racing Media Association (MRMA) and, for a number of years, wrote a weekly breeding column for *Daily Racing Form*.

Acton received Pimlico's Old Hilltop Award in 2006 for covering racing with excellence and distinction. The year before, MRMA had presented her its first Unsung Hero Award for her behind-the-scenes accomplishments throughout the Maryland Thoroughbred industry.

"Lucy was a dear friend to not only Maryland horsemen but to the entire Maryland racing community," commented MTHA President Richard Hoffberger. "Her hard work, dedication and loyalty to the MTHA will be dearly missed."

In addition to her two children, Jonathan and Katherine, Lucy leaves two brothers, Bruce and George, and her former husband, Jon.



MRMA Scholarship Apps Due September 23, 2011

September 23 is the deadline to apply for aid from the Maryland Thoroughbred Scholarship Fund for 2011.

Individuals employed on the backstretch at Maryland tracks, or farms, training centers or veterinary clinics in Maryland, and enrolled this fall in college or graduate school, will be considered for these scholarships.

More than \$30,000 is available this year through the fund, which is supported by various industry groups and individuals, including the MTHA and Maryland Horsemen's Assistance Fund.



MTHA Board of Directors 2011-2014

W. ROBERT BAILES



Elected to his first term as a MTHA Board member, Robbie Bailes has trained a successful public stable in Maryland for over 20 years.

Mr. Bailes' best runner to date has been graded stakes winner Scrappy T, the runner-up in the 2005 Preakness picked out and purchased by the trainer as a 2-year-old at OBS in Florida.

HOWARD M. BENDER



Howard Bender has served on the MTHA Board for the last 18 years and is Chairman of the Finance Committee.

Mr. Bender and his wife, Sondra, have about 30 horses based at Laurel Park and maintain one of the largest and most successful racing stables in Maryland, an operation composed almost exclusively by homebreds.

CHRISTINE E. BRICKER



An active MTHA member for many years, Chris Bricker has been elected to her first term on the MTHA Board.

Ms. Bricker became a Thoroughbred owner in 1997 and has a small operation, breeding her own horses to race.

An engineer by profession, Ms. Bricker is employed by Northrop Grumman.

DALE CAPUANO



Dale Capuano, a MTHA Board member since 1996, serves as chairman of the Negotiating Committee, handling the purse and stakes allocations.

Mr. Capuano has led Maryland's training ranks eight times and has to his credit 31 meet titles. He is also the all-time leading trainer in the Maryland Million.

LINDA S. GAUDET



Linda Gaudet, a member of the MTHA Board since its inception, is involved in nearly every facet of racing.

Mrs. Gaudet serves on the Maryland Racing Commission's Medication Committee, is a Director of the Maryland Horsemen's Assistance Fund and is chair of MTHA's Backstretch & Safety Committee for Bowie.

H. NEIL GLASSER



An MTHA Board member since 2005, Neil Glasser is one of Maryland's longest active owners. Retired from Chateau Builders, the new home building and site development firm he founded over 40 years ago, he bought his first horse in 1971. His top runners include stakes winners Sheeler and Coolmars.

CHRISTOPHER W. GROVE



Chris Grove has risen to the top of the training profession in the last several years and topped the standings in Maryland in 2010. He has 50 horses in his stable at Bowie for 15 different owners. Past and current stable stars include millionaire Silmaril and Barbara Fritchie Stakes-G2 winner Sweet Goodbye.

ARNOLD A. HEFT



Arnold Heft is among Maryland's most active and successful owners. He and his wife, Sylvia, have campaigned many winners and several stakes winners during more than 23 years in racing, with stable stars including Pulverizing, Baldski's Choice, He Is Risen, Ace's Orphan, Eighttofasttobet and Red's Round Table.

RICHARD J. HOFFBERGER



Richard Hoffberger has served as President of the MTHA since the organization's founding.

An active owner/breeder, Mr. Hoffberger is deeply involved with racing—as a horseman, a horsemen's representative and a businessman. He is president of The Hoffberger Insurance Group among other industry ventures.

MICHAEL F. HORNING



A first time Board member, Michael Horning comes from a family that has been breeding and racing horses in Maryland for over 40 years.

A graduate of John Carroll University with a degree in accounting, Mr. Horning is part-owner of several family owned horses trained by his brother Larry.

R. LARRY JOHNSON



Larry Johnson, a first time MTHA Board member, is the owner of Legacy Farm of Bluemont, Va.

Mr. Johnson has a stable of 25 race horses with conditioner Mike Trombetta based at Laurel Park.

Larry was also elected earlier this year to his first term to serve on the MHBA Board.

TIMOTHY L. KEEFE



A member of the MTHA Board since 2005, Tim Keefe is one of Maryland's most successful trainers, conditioning such runners as stakes winners Celtic Innis, Eighttofasttobet and Red's Round Table.

Tim also serves on the Boards of the Maryland Horsemen's Assistance Fund and Maryland Million.

RICHARD J. MEYER



The MTHA's Vice President since 2002 and a Board member since 1989, Rich Meyer is Chairman of the Health and Welfare Committee. He also serves as President of the Maryland Horsemen's Assistance Fund, Inc. (a group that works closely with the MTHA), and is a member of the Maryland State Fair Board.

Larry Murray, whose experience covers a wide variety of equine endeavours, is the private trainer for Sondra and Howard Bender's large and successful racing stable and general manager of their Glade Valley Farm, where he makes his home along with his wife of over 30 years, Janice.

Katy Voss has been a trainer in Maryland for over 40 years and played a role in the founding of the MTHA in 1987. The longtime Board member currently serves on the Negotiating Committee. 
Backstretch Appreciation Day

Thoughts and Comments

The Maryland Jockey Club is once again under the direction of a single ownership, Stron-MJC (Frank Stronach's new racing entity). Gone are the days of management's instability that included a struggle between two competing camps on the future of Maryland Racing.

In an attempt to bring some stability to the state's racing industry, the Maryland General Assembly passed legislation earlier this year requiring 146 days of live racing through 2013, in return for some financial relief. These race days are the lifeblood that sustain racing and breeding in our state.

Both the MTHA and the "new" owners must resist the urge to modify the agreements that were painstakingly created last winter. After the contracts were signed last fall, we collectively thought that the three-year time frame would be used to develop a new and better plan for our racing schedule and for the track to outline their marketing activity for the future.

We thought that any new plan would take a few years to develop and implement. The "new" Stronach organization has not yet commit-
