



Jockeys Guild Seeks Losing Mount Fee Increase

Terry Meyocks, Jockeys' Guild National Manager, outlined a request to the Maryland Racing Commission in September that called for an increase in minimum jockey mount fees in Maryland from their current levels to a flat fee of \$100 for purses up to \$99,999 and \$105 for purses above \$100,000.

Currently, minimum jockey mount fees are distributed on a sliding scale beginning at \$40 and ranging upward to \$100 for purses over \$100,000.

Maryland jockeys currently receive compensation from two other sources in addition to mount fees. First is a \$10 losing mount bonus paid on top of other fees. This losing mount bonus is restricted to jockeys with the majority of their mounts in Maryland, who rode 50 or more horses and earned less than \$100,000 in Maryland the previous year and is paid as a bonus at year end.

Second is a \$1.5-million contribution from the Purse Account to the Maryland Jockey Injury Compensation Fund to secure workmen's compensation insurance coverage, on a blanket basis, for Maryland jockeys. This Fund, is controlled by the Maryland Racing Commission.

The Jockeys Guild proposal is currently under consideration by the MTHA's Board of Directors with a formal position expected to be presented at the Maryland Racing Commission meeting on October 16th.

MTHA MAKES LEADERSHIP CHANGES

The Maryland Thoroughbred Horsemen's Association Board of Directors has elected owner Richard J. Meyer as its new President and Dale Capuano, one of Maryland's all-time leading trainers, as Vice President. The election represents the first major change of leadership since the organization's inception in 1987.

Richard J. Hoffberger, who has served as President since 1987, announced in May that he would not seek reelection.

Meyer, who has owned horses since the early 1980's, has been a Board member since 1989. As Chairman of the Health and Welfare Committee, Mr. Meyer has played an instrumental role in numerous programs that have improved the quality of life on the backstretch. These efforts have included the creation of the MTHA's Backstretch Pension Plan, Health Center, Free Health Fairs, and year-round Recreation Program among other initiatives.

Mr. Meyer also is a member of the Maryland State Fair Board and is the current President of the Maryland Horsemen's


Assistance Fund, a charitable group that provides financial assistance to eligible employees actively working at Maryland racetracks and/or thoroughbred farms.

A career employee of the Defense Department, Meyer is a 1981 graduate of the National Defense University. He graduated from St. Louis University, and earned a Master's Degree in technology and management from Central Michigan University.

Mr. Hoffberger will remain on the Board and continue to work on legislative issues. He will also continue his efforts on the MTHA's Negotiating Committee which is currently working on future racing dates and other matters relating to a long term racing program with the Maryland Jockey Club.

Also, after 37 years of service, the Association's Executive Secretary, Wayne W. Wright made official his retirement. The Board appointed David Richardson, who has served the Board as

Administrative Assistant since July 2011 as Mr. Wright's successor.



An Open Letter From Richard J. Hoffberger:

Having been President of the MTHA for almost three decades, I must say that it has been a very good run for me personally, and I believe for the MTHA. We've certainly done a lot together. There have been easy years, and times that were not so easy. There have been substantial changes in the industry, and there will be many more in the near future. I think this organization has been incredibly proactive in trying to stay ahead of the curve.

We have done many things extremely well. During the time of a reduction in the availability of dollars for purses, I believe that this organization has done a masterful job of

working with track management to maintain a year-round racing schedule that was the best that it could be. Not that it worked to everyone's satisfaction, but history demonstrates that it has worked very well. It worked well enough that most of our trainers were able to stay in Maryland and support Maryland racing.

I'm proud of the work that we have done, and I have to give a lot of the credit to Wayne Wright. Many, if not most, of the ideas for providing services to people that work on the track came from him.

If anyone has ever gotten sick, or needed medical service while at the track, thank Wayne for the idea to have a doctor work on the backside.

For every trainer that has had an employee be able to continue to work because they were able to have preventive care, thank Wayne for having an office built in the track kitchen building on the backside at Laurel. For every owner that has realized any savings in their training bills because they have a healthy work force, thank Wayne for the idea to have the doctor provide service free of charge to those licensed at the track. I believe that the MTHA was the first organization to provide this kind of full service.

When the track wanted to reduce medical staff in the morning, I was able to ensure that there would be quality medical service during training hours available, and Wayne was the person that led that push for all riders to have that benefit.

The implementation of the recreation program with a full-time recreation director was enabled by Wayne.

It was Wayne who helped shepherd in the drug and alcohol counseling program.

While the Maryland Horsemen's Assistance Fund has always operated as a separate entity from the MTHA, it has been Wayne's oversight that has brought untold help to thousands of horsemen in need over the past 37 years. To the thousands that have received help from the Assistance Fund, they should thank Wayne for his support.

For those that say that Wayne a gruff guy, they don't know the heart he has.

Combine that with his knowledge of the legislative process and understanding of how the racetrack works, and you have someone that can perform much more than one kind of task. I don't think that there is an executive in the horse business that has demonstrated time and again, for years, that they can provide help on the backside in the morning, negotiate with track management over lunch then have dinner with the governor. I've been lucky enough to see Wayne do that. Sure he was paid for his efforts, but he gave a lot more than he received.

In the past few years there had been more discussion than anyone would have liked over the number of days that we race. Wayne has been instrumental in helping maintain a balanced racing schedule. For that, every owner, trainer, breeder, groom, and front side employee that worked those days should thank him.

For my part, I've worked with about nine different Boards, five different track managements, five governors, hundreds of legisla-

Racing Media Association To Award \$26,750 In Scholarships For 2012

The Maryland Racing Media Association (MRMA) will disperse \$26,750 in scholarships to 23 men and women involved in the Maryland Thoroughbred racing industry.

This year's awards, made possible through the generosity and support of equine organizations as well as private donors, brings to more than \$325,000 in scholarships that have been dispensed over the past decade.

All of the scholarship recipients either work on the Maryland backstretch or are employed on a Thoroughbred farm.

Penn Gaming Could Buy Stake in Maryland Live Casino!

Penn National Gaming is in talks with the owners Maryland Live!, the state's largest casino, about acquiring a significant minority stake in the operation, according to two state officials familiar with the talks.



The arrangement has the potential not only to shake up the ownership structure of Maryland's fledgling casino industry, but also to affect an ongoing campaign over a gambling-expansion plan that will appear on the state's November ballot.

Maryland Live! is currently owned by a spinoff of the Cordish Cos., a Baltimore-based developer and entertainment firm.

Acquiring a significant stake in Maryland Live! would force some other decisions for Penn. Under Maryland law, companies may not have an ownership stake of more than 5 percent in more than one casino.

That could force Penn to sell its Cecil casino or somehow restructure its ownership. It would also an attempt to win a gambling license for Rosecroft more difficult to navigate.

The Maryland Jockey Club has begun using video insertion technology to deliver virtual distance markers and a virtual finish line to enhance the simulcast for Laurel Park's fall meet.

"This is a new, creative visual aid for fans to see how close the wire is and if their horse has a chance to win," said MJC President Tom Chuckas. "We tested it at Pimlico during Preakness week and got positive feedback, so we decided to move forward."

The technology was developed by International Sound Corp., in conjunction with a third-party vendor.
