Russell, Kobiskie win Laurel Winter Meet Title

The 12-week Laurel Park winter meeting ended with Sheldon Russell and Dane Kobiskie winning individual titles. The 48-day stand began at the central Maryland track on January 4 and ended March 24.

Russell, the top jockey in the Maryland colony a year ago, topped the rider standings with 54 first place finishes, 21 more than Malcolm Franklin. The 24-year-old had 16 multiple win days during the meet, including nine in the last four weeks of the stand.

Kobiskie won the training title at the winter meet for the second straight year with 34 victories from 81 starts, an impressive 42% winning percentage. The former rider conditioned seven runners who won multiple races during the meet, including Lady June Bug and Lipstick Traces, who visited the winners' circle three times.

Jamie Ness finished in second place with 23 wins.

Kobiskie's top owner, PTK LLC, led the owner standings, finishing first 29 times, six more than Midwest Thoroughbreds.

MTHA approves adjusted stakes payouts, Arabians

The Board of Directors of the MTHA voted unanimously at its March 21, 2012 meeting to endorse and approve a plan submitted by the Maryland Jockey Club's Racing Office that modifies the Maryland stakes purse payout structure by paying down to sixth place from the previous system which paid only to fifth place.

The new breakdown for stakes payouts, which began April 7 in the Mister Diz Stakes, is: 60% to first, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth.

"This change was the idea of my Stakes Coordinator to attract fuller fields for Maryland stakes. If owners know there's one more way to get a check, in some instances they are more likely to enter their horse in a stakes race," remarked MJC Racing Secretary Georganne Hale.

To fund this new payout, 1% was removed from the previous system's third-place finishers' payout and transferred to a sixth-place finisher.

In addition, the MTHA Board unanimously approved an emergency request from MJC

by conference call to endorse House Bill 597 "Horse Racing-Mile Thoroughbred Race-tracks-Payment of Taxes and Impact Aid and Arabian Breed Racing Authorization."

This emergency legislation, sponsored by Ways and Means Committee Chairman Sheila Hixson, was created to authorize limited Arabian racing at Maryland tracks under very specific conditions with no contribution requirements from the Thoroughbred Purse Account.

The purpose of this request by MJC management was to accommodate a potential international sponsor on Preakness Day. This sponsor has shown interest in conducting and funding an Arabian race early on the day's card, which requires legislative approval, with all pari-mutuel wagering proceeds distributed to Thoroughbred interests as a normally carded race.

Other requirements called for in this legislation are: no more than one race per day; no more than three races per meet; any Arabian race is to be conducted in addition to and not in place of an existing Thoroughbred race; and each Arabian race conducted must be approved and sanctioned by the Maryland Racing Commission.





In Memoriam

Longtime backstretch worker **James 'Pino' Jones** passed away on March 19 at the age of 69.

Jasmine D. Watkins, wife of 52 years to Maryland owner Robert Watkins and mother of trainer Shannon Watkins, passed away on March 17 after a long battle with cancer.

The Watkins family is best known for owning Smelly, an earner of \$308,862 from 26 starts while winning or placing in six stakes including a 10-length victory in the Grade 3 Federico Tesio Stakes.

Noted horsewoman and philanthropist **Mignon C. Smith** died February 10 of an apparent heart attack in Washington, D.C. She was 81.

Smith was an accomplished breeder and owner for 50 years, racing on the flat and over jumps. The horses she bred won over \$2.4 million in purses and included nine black-type winners.

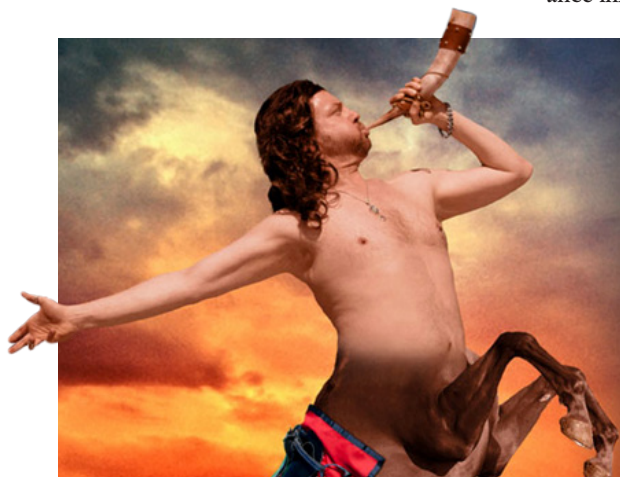
No Parking

Voted unanimously.

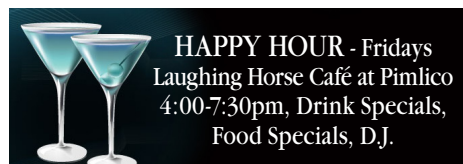

Jockey Club makes fatality database available

More than a dozen racetracks that participate in a horse racing industry fatality database, including Maryland tracks, have agreed to release statistics for their properties, according to The Jockey Club.

The Equine Injury Database was conceived after the breakdown of 2006 Kentucky Derby winner Barbaro in the Preakness Stakes, and launched in July 2008.

To encourage tracks' participation, the database organizers previously hadn't disclosed fatality rates for individual tracks. Now The Jockey Club will be making that data available through its website: www.jockeyclub.com.



Down the Stretch for Susan G. Komen returns

A week before the second jewel of the Triple Crown shines horse racing's spotlight on Baltimore, human runners will once again get the chance to dash around the historic Pimlico course, and raise money for a good cause at the same time.

The Maryland Jockey Club announced the return of the "Down the Stretch for SGK" Preakness 5K. The race will take place Saturday, May 12, at Pimlico Race Course, with part of the proceeds benefitting the Maryland Affiliate of Susan G. Komen for the Cure.

For the third consecutive year, runners will be able to compete on the Pimlico dirt course, where champion Thoroughbreds like Secretariat and Seabiscuit once ran, and finish in the legendary infield.

The 5K race will begin at 10:30 a.m. It will start on the parking lot at Belvedere and Park Heights Avenues and circle one mile around the Pimlico dirt course. The route will continue around the Pimlico perimeter before finishing in the infield.
