## Backstretch Pension Contribution Increases

The Board of Directors of the Maryland Thoroughbred Horsemen's Association has voted unanimously to increase the annual contribution to the Backstretch Pension plan by a third starting in 2013.

Established in 1988, the MTHA's Pension Fund is derived from monies deducted annually from the Thoroughbred Purse Account. The \$300,000 allocation has remained unchanged since the plan's inception and will increase to \$400,000.

Participants do not make individual contributions into the plan and anyone employed in the care of horses on the backstretch, including trainers, is eligible to participate in the Pension program. However, the employee must have worked a minimum of 1,000 hours during the specified year, and provide documentation to that effect (with a W-2 or 1099 form, or tax return). Benefits become available when the employee reaches the age of 65, or at age 55 with 25 years of service.

Participants in the plan must reg-

ister each year to be eligible for benefits.

The 2013 registration schedule begins March 25 at Bowie and ends May 3 at Pimlico. The full schedule with times and locations can be found on Page 4 of the *Horsemen's Newsletter*.

The increase was made official by the Maryland Racing Commission in January. The commission had to sign off on the increase before the increase could be implemented.

The Backstretch Pension plan is administered by William Whitescarver, vice-president of Investments from the Baltimore-based firm Chapin-Davis.

## New Claiming Changes and Waiver Rule Pending MRC Approval

Several Claiming Rule changes were proposed at the January MTHA Board of Directors meeting held January 24 at Laurel Park. The first two proposed changes are currently pending and do not become effective until they receive Maryland Racing Commission approval. The following is a list of the proposed changes:

1. The newly proposed claiming rule states that a horse that is claimed may not run for a claiming price less than the price for which it was last claimed for a period of 30 days. The claimed horse will only be eligible to run for a claiming price greater than or equal to the claiming price for which it was last claimed.

2. The MTHA Board also adopted a revised Waiver rule similar to that of the California Horse Racing Board and the Delaware Racing Commission, which were both adopted in 2008. The Waiver Rule states that if a horse has been laid-off and has not started for a minimum of 180 days since its last race and is entered for a claiming price greater than or equal to its last start, the owner may opt to declare the horse ineligible to be claimed.

This optional Waiver rule must be declared at the time of entry into a claiming race in the horse's first start after the layoff and is only allowed once.

3. The third revision to the claiming rule discussed at the January meeting states that no person (trainer or owner) shall be eligible to claim more than one horse per race. This revision clarifies the previous rule, which stated that no trainer is eligible to claim multiple horses out of the same race.

"I'm glad the Board adopted these new changes," commented Board Member Linda Gaudet, who proposed the changes. "The Waiver Rule option especially will help the trainer and owner who have a tremendous amount of time and money in a horse after a long layoff. This revision protects the owner and trainer from losing their horse in his first start back."

### Jazzy Idea Named 2012 Maryland-Based HOY

Edwin Merryman's dazzling filly JAZZY IDEA was selected as the 2012 Maryland-based Horse of the Year by the members of the Maryland Racing Media Association (MRMA) in voting conducted at the first of two bi-annual meetings held by the organization.

JAZZY IDEA, a daughter of Great Notion, won six of 12 starts, including five stakes races, and earned nearly \$400,000 last year at age 3 and concluded her campaign with victories in the Maryland Million Oaks and Laurel Dash.

Owned, bred and trained by Merryman, JAZZY IDEA edged BEN'S CAT by one vote for the honor, a fitting result considering that she rallied to defeat BEN'S CAT to capture the Laurel Dash on the turf and established a new course record.

JAZZY IDEA will be formally recognized as the Maryland-based Horse of the Year by the Maryland Racing Media Association on Saturday, February 23 in a trophy presentation just prior to the 22nd renewal of the \$125,000 MRMA Handicap at Laurel Park.

### Rosecroft Arbitration

The Board approved the terms of an agreement regarding cross-breed simulcasting between Standardbred interests (Prince Georges Racing Ventures LLC, Cloverleaf Standardbred Owners Association and Maryland Standardbred Breeders Association) and Thoroughbred interests (Maryland Jockey Club, Maryland Thoroughbred Horsemen's Association and Maryland Horse Breeders Association). **Voted unanimously.**

### Maryland Purse Protection and Retirement Program

The Board approved in concept funding *The Maryland Purse Protection and Retirement Program* with an optional ten dollar (\$10) deduction from owner's horsemen's accounts at time of start for each horse who starts a race in Maryland, pending Maryland State Board of Elections approval. Also, the Board approved a ten dollar (\$10) increase in the Bonus Award for 7th place through last in all races in Maryland. **The motion carried 8 for, 1 against.**

*Voting in favor were:* Mr. Bailes, Ms. Bricker, Mr. Capuano, Mrs. Gaudet, Mr. Glasser, Mr. Hoffberger, Mr. Keefe and Ms. Voss. *Voting against was:* Mr. Johnson.

### Horse Show Funding

The Board approved a contribution from the Thoroughbred Purse Account to assist funding *"The Maryland Charity Thoroughbred Horse Show"* at Show Place Arena on April 27 and 28, 2013. **Voted unanimously.**

### Drug & Alcohol / Health Center Funding

The Board appropriated up to \$40,000 from the Thoroughbred Purse Account as the MTHA's 2013 contribution to the Drug and Alcohol Program and appropriated up to \$60,000 from the Thoroughbred Purse Account for the 2013 operation of the Backstretch Health Center. **Voted unanimously.**

### Claiming Rule

The Board approved proposing a rule change that would deem claimed horses ineligible for a period of thirty (30) days to be re-entered for a claiming price less than the price that the horse was last claimed. **The motion carried 8 for, 2 against.**

*Voting in favor were:* Mr. Bailes, Ms. Bricker, Mrs. Gaudet, Mr. Hoffberger, Mr. Johnson, Mr. Keefe, Mr. Murray and Ms. Voss. *Voting against were:* Mr. Capuano and Mr. Glasser.

### Waiver Rule

The Board approved proposing a rule change that would permit an optional one-time waiver, to be declared at time of entry, which affords the ability to declare a horse ineligible to be claimed provided that the horse has not started for a minimum of 180 days since its last race and is entered for a claiming price equal to or greater than the claiming price of the horse's last start. **Voted unanimously.**

The Board granted its consent for the acceptance of interstate off-track wagers on the export of any live Maryland Thoroughbred race to an out-of-state wagering facility and the import of any live race from an out-of-state track run from January 1, 2013 through December 31, 2013. **Voted unanimously.**
