Nominations Sought For Backstretch Employees Of The Year

Trainers at Laurel Park and Pimlico Race Course are encouraged to submit nominations for the MTHA Backstretch Employees of the Year for 2017.

The MTHA, as it has in previous years, will recognize one backstretch employee at each racetrack based on the nominations. The awards will be presented in early 2018 at a special event that is in the planning stages.

The deadline to submit nominations is Nov. 15.

"Our backstretch workers are very important to our industry," said Bobby Lillis, MTHA Benevolence Administrator. "They arrive at the track in the darkest hours of the morning and are doing jobs that any nine-to-fiver just couldn't comprehend. They feed a barn full of horses, scoop manure from stalls, and lift hay, straw and water. The groom bathes them when they get back from the track – all before the rest of the world wakes up.

"They are very dedicated and spend most of the day making sure the horses are well taken care of. They always put the needs of the horse before their own. They know the personalities of their horses and every blemish on every inch of their bodies. The best feeling these workers experience is taking a horse in their care on race day and watching it come down the stretch to win or at least place well.

"They are indeed the force that makes it all happen, and we could not be here without them. We very much appreciate them."

2018 Maryland Racing Calendar Expands



The Maryland Jockey Club has scheduled 171 live racing programs for 2018, up nine days from 2017, under a calendar approved by the Maryland Racing Commission Oct. 26 and the Maryland Thoroughbred Horsemen's Association Oct. 30.

The schedule calls for 159 days at Laurel Park and 12 days at Pimlico Race Course. With another seven days at the Maryland State Fair at Timonium, there will be 178 live racing programs from Jan. 1-Dec. 31 with racing at least three days every week of the year.

The additional days will be held at Laurel, and almost all of them will be Mondays in August and December in keeping with a schedule change this fall by which Mondays replaced the regularly scheduled Thursdays on the calendar.

At Laurel, there will be racing four days a week in August and October through November on a Friday-through-Monday schedule. At Pimlico, there will be a four-day week and a five-day week with the three-day Preakness week in between – the same schedule as this year – with racing on Thursdays instead of Mondays with the exception of Memorial Day.

"Having four days a week is the most important thing," MJC President Sal Sinatra said. "We skipped (four-day weeks) in September for next year because we missed August this year. Parx is usually dark for most of August and Saratoga is open on Mondays."

Sinatra has said it's worth seeing if wagering on Laurel races on Mondays in August is strong because there are more gambling dollars available at racetracks and off-track betting parlors and through advance deposit wagering services when Saratoga is open.

The 2018 schedule is subject to change because, as has been the case the last few years, additional dates were added to the calendar. It was noted at the MTHA board meeting that if handle and purse projections hold for next year, September could go to four days a week.

Change Recommended For Dual License Suspensions

A Maryland Racing Commission committee has recommended a change in a regulation dealing with dual licensees but said additional discussion is necessary regarding the suspension of horses that test positive for Class 1, 2 and 3 substances.

Under current policy in Maryland, a suspended trainer who also holds an owner's license can continue in good standing as an owner.

MRC Executive Director Mike Hopkins, during the commission's regular meeting Oct. 26, said the committee recommended suspensions pertain to all licenses held by a suspended individual.

The committee was comprised of representatives of the MRC, Maryland Jockey Club and Maryland Thoroughbred Horsemen's Association.

Hopkins said a proposed revision to the regulation has been sent to the governor's office for review and will be brought before the MRC for consideration at a future meeting.

In a related matter, Hopkins said the MRC is developing guidelines for stewards and judges in relation to the transfer of responsibility when a trainer is suspended. The officials would be able

to view payroll information, purse payments and other documents to determine whether horses truly change hands during a suspension.

"We want to try to make it more uncomfortable for a trainer who is in these situations," Hopkins said.

As for the suspension of horses after a split sample confirms a positive

– Pennsylvania recently adopted such a regulation – the committee identified a number of logistical issues, Hopkins said, and decided to continue discussions rather than make a recommendation. He said "a number of ideas" came out of the committee meeting on ways to improve integrity.

"This is not the end of the discussion, this is the beginning of the discussion," MRC Chairman Mike Algeo said.

The MTHA board of directors at its Oct. 30 meeting approved a motion to support the change in the dual-license regulation in order to keep suspended trainers from claiming horses under their owners' licenses.

Email System For Horsemen's Concerns Speeds Up Response Time By MJC

The newly created email system for reporting backstretch and track surface concerns by Maryland horsemen has drastically improved response time by Maryland Jockey Club to address concerns at Laurel Park and Pimlico.

The MTHA created the system in early summer to improve communication among horsemen and track maintenance staff to expedite the process of issues being addressed.

Previously issues were communicated by horsemen by a paper-based ticket system which proved cumbersome.

Horsemen are now encouraged to send emails, with photos, of their concerns to backstretchissues@mdhorsemen.com for backstretch concerns or to track-issues@mdhorsemen.com for track surface issues.

Messages to each of these accounts are forwarded to a multitude of relevant parties as well as to the MTHA so progress and response time can be tracked.
