More H2B Visas Hopefully On The Way



The American Horse Council in an industry memo June 23 said the United States Department of Homeland Security expects to begin issuing another round of H2B visas in late July.

Additional H2B visas, which are critical to the horseracing industry in regard to finding backstretch workers, were included in a congressional budget bill that became law in the spring. Issuance of additional visas, however, is up to the discretion of the DHS.

Published reports have indicated the department plans to issue more visas, though it declined to say when and how many. The cap of 66,000 was met within the first 30 days of 2017, which created a hardship for horse racing and various agricultural industries that rely on seasonal help.

"The extra visas will be available to employers that show they'd be significantly harmed if they aren't able to temporarily hire foreign workers," the AHC said. "DHS hasn't decided how many visas will be offered but that number should be set soon."

Trainers in multiple states have reported difficulty in finding enough grooms to care for their horses at race tracks.

"This crisis impacts not just racing," said Alan Foreman, Chairman of the Thoroughbred Horsemen's Association. "Racing is a small part of a much larger service industry in the United States. We are working on this issue at the very highest levels in Washington, D.C. It's a political issue, not a legal issue."

Foreman said the THA is working with state racing

2017 Board of Directors Election Ballot Set

Twenty-nine individuals, including 14 incumbents, are seeking the 15 seats on the MTHA board of directors in this year's election.

MTHA directors serve three-year terms. The board has seven owner directors, seven trainer directors, and one at-large seat filled by the highest vote-getter of the remaining candidates.

Horning, Johnson, Manfuso and Reed are incumbents.

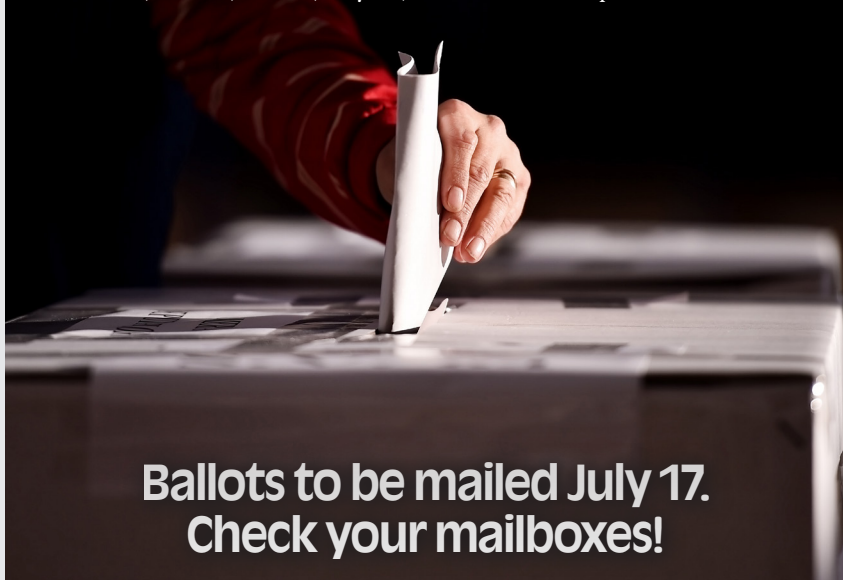

Included with the ballot will be detailed candidate biographies and photos. Completed ballots must be received back – not postmarked – by Aug. 15 and will be counted by an independent auditor, Election Trust of Washington State, Aug. 21.

Officers are selected when the new board holds its first meeting, which is scheduled for September.

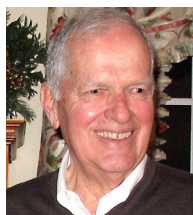

THA, MTHA Among Groups Opposing Federal Bill

Roughly 50 groups that represent horsemen in North America co-signed a letter to the leaders of two Congressional committees voicing their opposition to the Horseracing Integrity Act of 2017.

The signatories are the Thoroughbred Horsemen's Association and its six affiliates, including the MTHA; the National Horsemen's Benevolent and Protective Association and about 25 of its affiliates; the Thoroughbred Owners of California; the California Thoroughbred Trainers; and Harness Horsemen International and its 15 affiliates.

The legislation, introduced in late May, is a revised version of the Thoroughbred Horseracing Integrity Act of 2015. The bill now includes the Standardbred and Quarter Horse industries.

As noted in the joint letter, other groups that oppose the legislation are the Association of Racing Commissioners International, which represents independent state racing regulatory bodies; the American Association of Equine Practitioners and the North American Association of Racetrack Veterinarians, the principal organizations representing the equine veterinary community; and the American Quarter Horse Association, the governing body for Quarter Horse racing in the United States.

Accompanying the letter to lawmakers was opposition statements issued by the AAEP and AQHA, as well as an editorial written by AAEP Racing Committee Chair Dr. Jeff Blea, who reaffirmed the organization's commitment to the health and welfare of the horse, which includes use of race-day Lasix until a viable alternative is discovered.

The joint letter states that the bill "is not in the best interests of the racing industry and is an ill-conceived effort by certain special interests to impose their minority views on the regulation of our industry. We have deep reservations about the provisions contained in this proposal because of its potential adverse impact on animal welfare and the economics of the industry."

The current version of the Horseracing Integrity Act calls for a ban on race-day Lasix beginning Jan. 1, 2019. The signatories said the legislation is being sold as an attempt to enact

nationwide uniformity on the use and regulation of therapeutic medication in racing but in reality is "nothing more than a smokescreen for the elimination of a safe, effective, necessary and tightly regulated medication that is given on race day to protect horses from bleeding in the respiratory tract."

Thoroughbred horsemen's groups across the country – and particularly those in the Mid-Atlantic and Northeast regions – have been largely responsible for facilitating cultural changes that led to the creation and ongoing adoption of the National Uniform Medication Program.

The letter states that the Horseracing Integrity Act, known as H.R. 2651, "purports to create a system for the uniform regulation and use of medication in the racing industry, but such a system already exists and it works well. Performance-enhancing drugs are not allowed or tolerated in horse racing. There is total uniformity on this issue in every racing jurisdiction, and racing has rules, policies, and laboratory testing that are superior to any sport or business in the world."

The signatories noted that the current regulatory system includes thoughtful deliberation and dialogue that includes input from an important array of organizations including the Racing Medication and Testing Consortium, which serves as the industry scientific arm and develops many of the model rules that are examined and promulgated by ARCI.

The bill, they said in the letter, would replace the current system "with one controlled by the federal government, with governance placed in the hands of hand-picked uninformed and unqualified individuals who known nothing about the racing industry or the health and welfare of the horse." The legislation would place the United States Anti-Doping Agency, which has no experience in horse racing, in charge of equine medication policy, testing and regulatory enforcement.

The letter also points out the Horseracing Integrity Act would create new federal bureaucracy and impose unlimited new taxes—particularly on horse owners—via an unfunded mandate.
